

# BELFAST WORKERS PENSION COMPENSATION



**We are successfully claiming compensation for many workers who transferred OUT of their work pension scheme.**

Many Belfast workers were advised to transfer out of their work pension scheme to a private scheme which paid considerably less! This was bad advice and many retired workers or their widows have lost out!

## Example 1 - £82,000

Mr R. from **NEWTOWNARDS** worked at **HARLAND AND WOLFF**. After the yard was privatised in 1989, he was advised by a salesman to transfer his pension to **ROYAL LONDON**. When he retired, he noticed that his pension was much lower than his friends who stayed in the **HARLAND AND WOLFF PENSION SCHEME**.

Compensation £82,342.

## Example 2 - £71,000

Mr R. from **DUNMURRAY** worked at **SHORTS**. After he finished there in 1993, he was advised by a salesman to transfer his pension to **STANDARD LIFE**. When he retired he realised he was getting a much lower pension than his friends who stayed in the **SHORT BROTHERS PENSION SCHEME**.

Compensation £71,843.

## Example 3 - £34,000

Mrs M. from **HOLYWOOD** worked at **STANDARD TELEPHONE**. After she finished there in 1993, she was advised by a salesman to transfer her pension to **ROYAL LONDON**. When she retired, she noticed that she was getting less than her friends who kept their **STANDARD TELEPHONE PENSION**.

Compensation £34,252.

## Example 4 - £96,000

Mr M. from **BANGOR** worked for **HARLAND AND WOLFF**. After he was finished there, he was advised by a salesman to transfer his pension to **PRUDENTIAL**. When he retired he realised that his pension was much lower than his friends who kept their **HARLAND AND WOLFF PENSION SCHEME**.

Compensation £96,942.

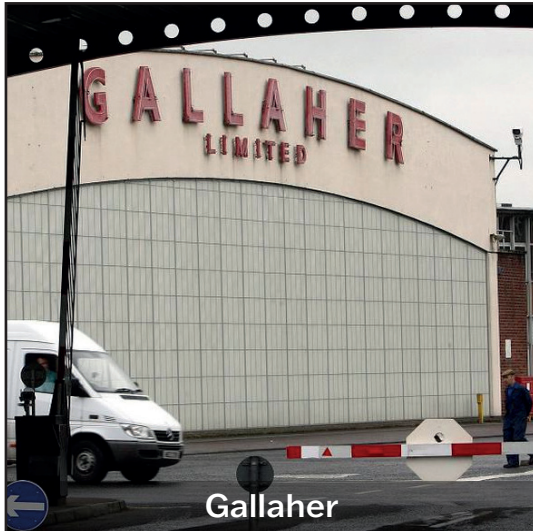

## Example 5 - £48,000

Mr W. from **CARRICKFERGUS** worked for **CARRERAS**. After the factory closed, he was advised by a salesman to transfer his pension to **SCOTTISH WIDOWS**. When he retired he noticed that his pension was much lower than his friends who kept their **CARRERAS** Pension. Compensation £48,000.

## Example 6 - £25,000

Mrs E. from **NEWTOWNABBEY** worked at **GALLAHERS**. He was advised by a salesman to transfer her pension to **PRUDENTIAL**. When she retired she noticed that her pension was much lower than her friends who kept their **GALLAHERS** Pension. Compensation £25,734.

## Example 7 - £85,000

Mr N. from **DUNDONALD** worked for the **EASTERN HEALTH AND SOCIAL SERVICES BOARD**. After he left in 1992, he was persuaded by a salesman to transfer his pension to **PEARL ASSURANCE**. When he retired he noticed that he was getting less than his friends who kept their **DEPARTMENT OF HEALTH** pension. Compensation £85,883.

## Example 8 - £76,000

Mr D. from **LISBURN** was a driver for **BELFAST CITY COUNCIL**. After he finished there in 1995, he was advised by a salesman to transfer his pension to **SUN LIFE (now AVIVA)**. When he retired he noticed that his pension was much lower than his friends who kept their **LOCAL GOVERNMENT** Pension. Compensation £76,793.
